BYE LAWS OF SUPER DIVISION FOOTBALL LEAGUE 2024

- 1. Total no of teams (10) will be divided in 2 (Two) groups (5+5).
- 2. Matches will be played on single Leg basis.
- 3. The match will be (45+45) in each half with 15 minutes break in between.
- **4.** Top 2 (Two) teams from each group will be placed for Knock Out (Winner of Gr.A vs Runner up of Gr.B and Winner of Gr.B vs Runner up of Gr.A)
- **5.** Winners of both the Group will play in Super Division Football Final to determine Champion & Runner Up team for the year 2024.
- **6.** Lowest point holder team of each group after completion of group league match will be directly relegated to Senior Division Football for the year 25-26 season. If the point is same goal average will be followed.
- 7. Total no of registration is restricted to 40 (Forty) including LIEN Players.
- 8. Only 4 (Four) LIEN Players are permitted to play in a particular Match
- **9.** For registration of Local & Lien Players, at least 4 days before, the forms should be submitted to the Association, falling which request for registration may be rejected.
- **10.** For LIEN Players separate forms to be filled along with the Aadhar Cards of the Player(Mandatory) Rs. 500 (Rupees Five Hundred) to be deposited at the time of deposit the forms.
- 11.Only 21 players + 7 officials are allowed to enter the ground and seat in the reserve bench.
- **12.** As per the present regulation of AIFF and IFA, 5 (Five) substitution can be made during the match.
- **13.** First Name team in the Fixture shall be treated as Home Team and is requested to use Left Side Reserve Bench.
- 14. Match will be held at Eastern Ground, Chinsurah. KICK OFF TIME: 3.00 P.M
- 15 Each team will carry 2 pcs of Cosco Milano Ball compulsory
